JNF TRAVEL WAIVER

In consideration for my participation in the Israel trip organized by Jewish National Fund (JNF), I hereby acknowledge, understand, and agree to the following terms and conditions:

1. I understand that the trip may involve air and other travel to and from my home to Israel as well as tours by bus or car, sightseeing and a variety of other planned and unplanned activities in Israel and the territories. I am aware that the U.S. Department of State regularly issues travel warnings and travel alerts about travel to Israel and the territories and that these warnings and alerts are available on the website of the US Department of State: <http://travel.state.gov/content/passports/english/country/israel.html>. I have read, or have had the opportunity to read, these U.S. Department of State travel warnings and travel alerts, and I understand the security risks inherent to such travel, and I assume such risks.
2. Notwithstanding any security arrangements that may be made by Jewish National Fund or any other party, I understand that JNF does not guarantee the personal safety and property of participants while they are participating in the JNF program or any other program-related activities, including airline travel, ground transportation, meals, lodging, recreational activities and other events. I hereby affirm that my participation in this tour is voluntary and that I am aware of the risks related with traveling overseas, and I agree to abide by the security directives issued during the course of the tour.
3. I understand that Jewish National Fund strongly discourages participants on the trip from making or participating in excursions or day trips separate and apart from those arranged, planned or provided for by JNF, and should I choose to do so, I acknowledge that I will be doing so at my own risk and all of the described waivers of responsibility and releases from liability apply to such circumstances. I further acknowledge that JNF is not responsible for me if I choose to extend my stay in Israel before or after the organized JNF program.
4. The tour program demands participants to be in stable physical and mental health, and confident in their ability to undertake all activities reflected in the itinerary. It is required that physical disabilities of any kind be advised at the time of registration. It is understood that participants requiring special attention or treatment will be traveling with a companion. I hereby confirm that I have consulted my physician within the last 6 months, and that physician has advised me that I am in good health and fit for extended travel, including the venues and activities chosen for this trip.
5. I acknowledge and agree that JNF and its affiliates, employees, officers and their successors shall have no responsibility or liability to me or any member of my family for personal injury, death, property loss or damage or any other loss or damage resulting or alleged to result from their negligence or breach of contract in connection with the trip.
6. I understand that JNF relies on independent contractors to provide services for this trip, including air and ground transportation, food, lodging, meeting facilities and other services. I understand and agree that all receipts and tickets issued by independent contractors are subject to terms and conditions specified by the independent contractors. I also understand that JNF is not responsible for any negligence of those independent contractors and/or their employees.
7. I acknowledge that the personal data I share with Jewish National Fund, such as my name, address and passport information, will be used by JNF to organize and facilitate my trip. I acknowledge that this may require my data to be shared with third parties, such as travel providers. I acknowledge that for these purposes my information may be transferred to, or stored or processed in, other countries which may have different levels of data protection or privacy laws.
8. I hereby grant permission to Jewish National Fund and its affiliates and agents, to reproduce, publish, distribute, publicly display, publicly perform, and/or create derivative works (adaptations) of my name, bio, statements, photographs, video, or any other form of media, without limitation. I consent to JNF allowing representatives of media organizations to request my participation in media interviews, although I have no obligation to accept participation in media interviews. Unless otherwise protested, I hereby waive any right to inspect or approve the finished media product that may be used now or in the future, whether that use is known to me or unknown, and I waive any right to royalties or other compensation arising from or related to the use of the media. I hereby agree to release and discharge JNF from and against any claims, damages or liability arising from or related to the use of the media.

9. I understand and agree that the laws of the State of New York will govern any dispute arising from my participation in this trip, whether arising in contract, tort, or some other body of law, whether brought by me or anyone claiming a right derived from me, as well as the interpretation of this agreement without giving effect to any conflicts of laws rules which may result in the application of the laws of any other jurisdiction.
10. Code of Conduct: Jewish National Fund reserves the right to dismiss any participant should their behavior conflict with the code of conduct required during a JNF tour. I agree to abide by the code of conduct set forth by the JNF staff member(s) and/or travel service representatives before and throughout the duration of a tour.

Code of Conduct

The Jewish National Fund's ("JNF") Code of Conduct applies to all persons registered for a trip and/or tour in Israel organized or operated by JNF Travel and Tours ("Participant").

Participant, JNF staff and Participants acting as Mission Chairs must exemplify the highest standards of behavior outlined in the Code of Conduct and proactively promote its practice amongst the entire length of the trip.

Abiding by the Code of Conduct means that you:

1. Participate in all planned group programming and do not diverge from an activity without permission.
2. Do not engage in illegal activity, acts of violence or vandalism, disorderly conduct or harassment of any kind, as determined by JNF in its sole discretion.
3. Do not allow any unauthorized person to gain access to trip activities intended exclusively for Participant.
4. Help to create a safe group environment, respect peoples' personal information and refrain from using their information for personal gain without consent.

JNF reserves the right to dismiss a Participant from a trip for any reason and JNF shall make any such determination in its sole discretion. JNF further reserves the right to bar any Participant from registering for any future trips should their behavior violate this Code of Conduct. Participant acknowledges that in the event of dismissal from a trip, Participant is responsible for all expenses incurred from the date of dismissal, including accommodations, as well as for the original cost of airfare and of the return to Participant's point of origin. Participant shall be responsible for reimbursing JNF for expenses incurred as a result of Participants violation of the Code of Conduct. By agreeing to this travel waiver, I consent to abide by this the code of conduct and any trip protocols set forth by JNF, JNF staff member(s) and/or travel service representative(s) before and throughout the duration of a tour.

I affirm that I am in sufficient health to participate in this tour and that I do not have any medical condition which would inhibit or prevent my full participation unless otherwise advised at time of registration.
