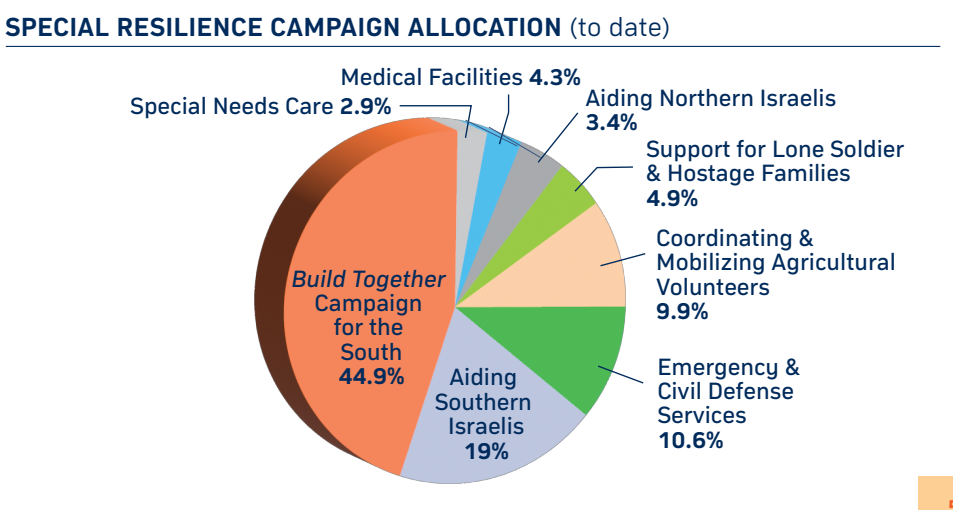
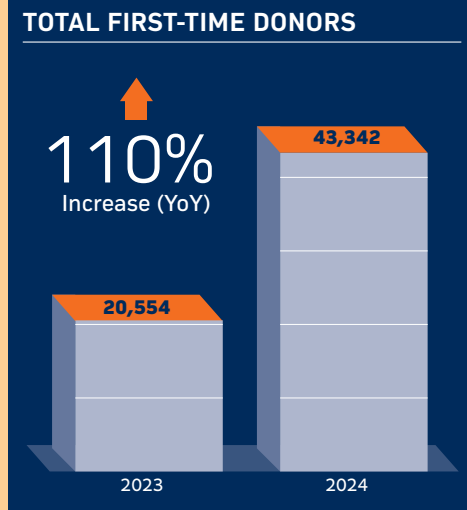
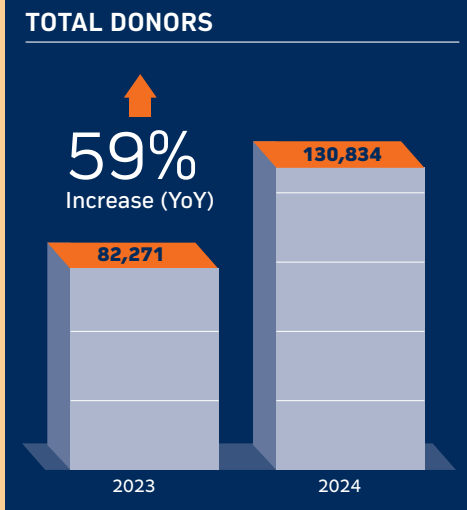
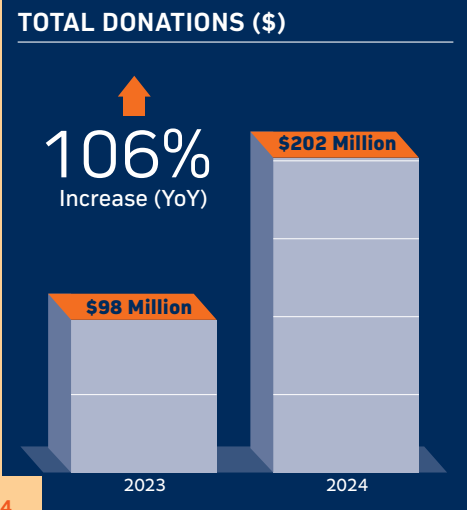
Spring semester began on time and uninterrupted in January at **Alexander Muss High School** in Israel, just months after the students were sent home in the wake of October 7

As of September 30, 2023, Jewish National Fund had financial reserves of \$363,262,250 without donor restrictions or about 3.3 times its 2023 annual expenses, which totaled \$109,317,031. Of the reserves, 51% has been designated by the board of directors for specific uses.
